Disclosure and Information

This application is used to help us determine your contractor/wholesale rate. Once a rate has been assigned and your application has been approved, we will contact you either by the phone number or the business email address you provide to discuss your pricing. Completed Applications may be sent to our email at: Gatlin@GatlinsStraw.com.

Please note that payments are due at the time of service.

If you decide to fill out a Credit Application, the application must be approved by our accounting department first. No sales may be put on a charge account until the Credit Application is approved and set up. Credit applications are only available to our contractors and wholesalers and can be sent upon request. Failure of payment on charge accounts will be subject to interest charges and will also cancel your contractors/wholesale rate indefinitely. (more information is disclosed in Credit Application Package)

Our minimum orders for Contractor/Wholesale Rates are 750 bales or more per order with a minimum of 2 orders per month (Totaling 1,500 bales minimum order per month) for any 6 months out of the year. (9000 annual bale order minimum) We are aware landscaping is seasonal, hence why we do not require a 1,500/month 12 months out of the year.

If your company is a wholesaler, and is to be tax exempt, please attach your tax exemption forms to this application.

After this application is approved, pricing is set, and you accept; A contract will be sent over for you to sign and approve. The contract will have the details of your orders already pre-placed and arranged with either your requested specific dates, during a designated month span, or specified time frame. Cancellations must be made 24 hours in advance and must be rescheduled within your Contract year.

If there's a breach of our contract, you will be responsible for 25% of the remaining balance due of your annual order contract immediately, and you will lose your contractor/wholesale rate and account indefinitely. If a natural disaster, or an uncontrollable event should take place affecting either the supplier, Gatlin's Straw, LLC, or the purchaser, then some exemptions can be made with no altering effect to your account status. These guidelines will be listed in your contract as well.
